Orientation cum Awareness for First-Year Students and ICC Elections for first-year student Representative <u>BHARATI COLLEGE</u> <u>2022-23</u>

Internal Complaints Committee, Bharati College, University of Delhi, functions effectively and collectively with its Presiding Officer, Member Secretary, faculty members, non-teaching staff members, and the external member who are rigorously assisted by its student body. Every year, ICC holds a general student body election for the purpose of selecting an eligible student for the post of ICC-first year representative. The post is open to all the students enrolled in the regular courses of Bharati College, University of Delhi.

Before announcing the elections, the committee decided to conduct an orientation program for the first-year students to spread awareness about its work and the upcoming election for the position of First-Year Representative. It was conducted on January 8, 2022, on the Zoom platform. A WhatsApp group was made for connecting to the first-year students of the college and sharing information related to ICC orientation and elections of the year 2022-23. The program was successful in terms of engendering awareness about ICC and clarifying the doubts of students.



After successfully conducting the orientation cum awareness program, a meeting of the ICC members was held on the same date 8th Jan 2022 to decide the election date for ICC's first-year student representative 2022-23. It was then decided that the election date for the position of ICC first-year representative will be 20th January 2022.

A google form was created inclusive of the application form and then shared on various Social Media platforms to invite nominations for the post till 11th January 2022. We received 28 responses from which screening of all the candidates was completed on the 13th of January 2022 through an online meeting. After doing a thorough screening on the basis of the questions asked in the Google form candidates are selected for standing in the elections (on the basis of their knowledge related to the term ICC and how effectively they will fulfill the role of being a representative of ICC. The task of screening the candidates was painstakingly completed by faculty members and the second and third-year student representatives. The final list of selected candidates was published and four candidates were shortlisted: Aliza Arif, Nisha Verma, Pushti Gogia, and Suhani Sabharwal. It was then followed by campaigning through posters, video, and audio messages from 14th-19th January 2022 (midnight).

5. In the message, you can talk about what is ICC and why one should elect you for being its representative.



The Internal Complaints Committee (ICC) is established in Bharati College, 2015 under the University Grants Commission (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Education Institutions) Regulations, 2015. It comprises students (one student chosen democratically from each of the three years), a Presiding Officer, two or three faculty members, two or three non-teaching employees, and one outside member from a non-governmental organization or association committed to the cause of women or a person familiar with the issues relating to sexual harassment, nominated by the Executive Authority.

ICC, Bharati College deals with cases of sexual harassment of the students or employees in the college and provides a mechanism of dispute redressal. It advocates the empowerment of women and has zero tolerance for any kind of sexual harassment. ICC diligently works toward providing a secure environment to students, teaching, and non-teaching staff. Complaint boxes have been placed on the college premises.

Sexual Harassment is defined as:

"An unwanted conduct with sexual undertones if it occurs or which is persistent and which demeans, humiliates or creates a hostile and intimidating environment or is calculated to induce submission by actual or threatened adverse consequences and induces any one or more or all of

the following unwelcome acts or behavior (whether directly or by implication), namely:

(a) any unwelcome physical, verbal or non-verbal conduct of sexual nature;

(b) demand or request for sexual favors

(c) making sexually colored remarks

(d) physical contact and advances

(e) showing pornography".

If a student, faculty member, or non-faculty staff member faces any discomfort under the above-mentioned heads, he or she can directly approach the committee.

An aggrieved person is required to submit a written complaint to the ICC within three months from the date of the incident, and in case of a series of incidents within a period of three months from the date of the last incident. Provided that where a such complaint cannot be made in writing, the Presiding Officer or any Member of the Internal Complaints Committee shall

render all reasonable assistance to the person for making the complaint in writing. For the reasons accorded in the writing; the ICC could extend the time limit by a period not exceeding three months if it is satisfied that the circumstances were such that prevented the person from filing a complaint within the said period. Friends, relatives, colleagues, co-students, a psychologist, or any other associate of the victim may file the complaint in situations where the aggrieved person is unable to make a complaint on account of physical or mental incapacity or death.




