- (iv) Character certificate (recent).
- (v) Proof of University of Delhi Enrolment number (wherever applicable).

### **IMPORTANT INSTRUCTION FOR CANDIDATE**

- (i) Applicants are required to bring the above-mentioned documents in original at the time of verification/payment of fees.
- (ii) Applicants are required not to leave any column blank. Application forms with any column left blank will be deemed incomplete and will not be considered.

### **Note:**

1. It has observed that a large number of students face difficulty in getting their photographs and other documents attested for submission to the University/College. To avoid this difficulty, the University has decided to accept the self-attested copies of documents/papers provided by the students. However, it is made clear that if any false attestation.
