- The candidate must be a regular, full-time student of the College. (Attach your I-Card/Fee Slip)
- Each candidate can contest only TWICE for the post of an office-bearer (President, Vice-President, Secretary, Joint Secretary or Treasurer). This rule does not apply to Class Representative.
- 3. Nomination Form must be filled in by the candidate herself and should be submitted duly completed and signed by the Proposer and Seconder, latest by schedule as declared by the Election Committee.
- Withdrawal will be permitted only if it is submitted in writing by the candidate in person, together with her Identity Card/Fee Slip by latest by schedule as declared by the Election Committee.
- 5. A candidate can file nomination for more than one post. Separate forms have to be filled. However, one candidate can contest election for only one position.
- 6. The age of the candidate must be less than 22 years (if undergraduate student) or 25 years (if post-graduate student) as on 16 August 2023.
- 7. The attendance for the previous academic year must not be less than 75%.
- 8. The candidate has no academic arrears in the year of contesting the election.
- 9. Office bearer of departmental/other societies have to surrender their office, once elected in the Union.

  - b) Date of Birth Certificate (Xth Class Certificate)
