---- The GB has gone through the case of Dr Fatima Hussain and had a very detailed discussion about it and observed the following two:

- The earlier decision of the GB to put Dr Fatima Hussain under suspension from 24th July 2013 is in operation and Dr Fatima is still under suspension for more than 8 years without any review during the period of suspension.
- The earlier decision of the GB in its meeting on 22<sup>nd</sup> Nov. 2014 regarding Compulsory Retirement is not operative and no new development has taken place in this regard for the last 7 years.

Seeing the facts of the case and the principle of natural justice, the GB resolves as follows:

- The Governing Body decides to revoke the suspension of Dr. Fatima Hussain with immediate effect. However, it was further decided that she will not be entitled for any increments during the suspension period. Further, she will give a bond of good behaviour and has to submit a medical certificate for fitness within a month of joining.
- The GB further decides that the earlier decision of the GB of Compulsory Retirement may also be revoked.
- 4. To report guidelines received from the Research Committee regarding publication of Journals in the College.

----The G. B. decided that an amount of Rs.25,000/- per year to be kept aside for the Publication, and the utilization of the same will be as per the rules and regulation of the College. It is further decided that the University of Delhi is to be asked to give money under Research Head.

- To report a request received from Ms. Uma Grover, Assistant Professor, Department of Commerce via mail on 24.09.2021 for Endowment Fund of Rs. 3,51,000/- for the students of B.Com. Her request was for the endowment fund for Bharati Golden Jubilee Merit Scholarship for students.

- 3. A request received from Dr. Anupama Mahajan, Professor in the Department of Commerce and the Convenor ICC for raising the ICC Fund Fee from Rs.10/- to Rs.50/-.

The request received has been forwarded to the Principal and the Principal informed that she shall have a meeting to discuss the modalities to take this project forward.
