3. You are requested to contact other members of the Board for setting of question papers as per the attached guidelines. **You are also requested to ensure that the board of paper setters moderates the question papers before submission.**
4. **Only the convener of board of paper setters is responsible and authorised to submit the moderated sets of question paper (separate pdf file for each set) at email id: ugexam@commerce.du.ac.in strictly without marking cc or bcc to anyone else to maintain utmost confidentiality and secrecy.**
5. Keeping in mind the secrecy and security, the question papers (moderated) are to be communicated through **Password Protection in MS-Word or PDF**. For seeking the

password, Mr. Pradeep Yadav from Department of Commerce will personally call you over phone .

6. Last date for submission of paper is 26/04/2021 i.e. within one week.

7. The subject of the mail is to be the Unique paper code_Semester_Set1,2,3_Programme_Course. (e.g. 62411106_Sem1_Set1,2,3_BA)

8. Each file to be attached should be named as Unique paper code_Semester_Set1_Programme_Course. (Eg. 62411106_Sem1_Set1_BA; 62411106_Sem1_Set2_BA; 62411106_Sem1_Set3_BA)
