Dear Sh. Bipul ji,

I am happy to inform you that the Expert Committee constituted by the Ministry of Culture, Government of India based on the proposal submitted by you has selected you for award of Junior Fellowship for 2015 - 2016 in the field of Classical Music Sub-Field Hindustani (Vocal) for a period of two years with effect from 01-07-2017. The value of the Fellowship will be Rs. 10,000/- per month and the same will be released in 4 six-monthly instalments as per present provisions.

The Centre for Cultural Resources and Training (CCRT) will require a six-monthly Progress Report as per the schedule overleaf. The first and the second instalments of Fellowship will be released on the receipt of 1<sup>st</sup> and 2<sup>nd</sup> six monthly Progress Report, respectively. The third instalment will be released after review of progress of your 1<sup>st</sup> and 2<sup>nd</sup> six-monthly reports by an Expert Committee and after the receipt of your 3<sup>rd</sup> six-monthly progress report. On completion of the Project, one bound copy of 2 years' complete Project document will have to be submitted to CCRT. The fourth instalment will be released after the 4<sup>th</sup> six-monthly progress report and the bounded copy of the complete Project document are received and evaluated by the designated Expert Committee. The last date for submission of the complete Project Report is **June 30, 2019**. However, in exceptional circumstances extension of time by maximum three months will be permissible without any additional financial liability to the Government of India/MoC/CCRT.

The six-monthly research reports should contain details of the work done by you during the relevant period of six months, and in addition it should also contain evidence of your work, which may be in the form of Photographs, Press Reviews, Survey work, etc.

It may please be noted that the Government of India/Ministry of Culture reserves the right to discontinue the grant of the Fellowship at any time if and when after review/enquiries, etc. Ministry of Culture comes to the conclusion that you have either abandoned the Project work or are not pursuing this work seriously.

You are also required to send the proof of leave from your organization if you are regularly working in a Government /State Department/University/Establishment/Institute, etc. The Fellowship is liable to be cancelled in case the **proof of leave** is not sent.

In case you are getting pension from this Ministry under the Scheme of "Financial Assistance to Artistes in Indigent Circumstances", you will have to opt for either of two: grant of Pension or grant of Fellowship.

A Digital Database Performa is also attached which has to be duly filled and send to CCRT.

The Project Report will be a **copyright** of Ministry of Culture /CCRT and will be used for further reference, research & educational purpose. Once again, while congratulating you on award of Fellowship, we sincerely hope that your scholarship will do a lot of good in understanding the layered traditions in our country.
