



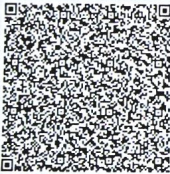

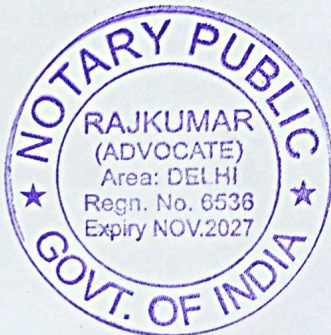

AND

Bharati College, a constituent college of the University of Delhi, located at C-4, DDA Colony, Phase II, Janakpuri, New Delhi – 110058, represented through its Principal, _____ (hereinafter referred to as Party No. 2)

General Terms

No Financial Commitment at MoU Level

This MoU does not involve any financial obligations for either party at the time of signing. Each specific activity proposed under this MoU will be reviewed and approved separately by the heads of both institutions, with terms mutually agreed upon.

Approval of Activities

Every activity conducted under this MoU shall be carried out only after written approval from both the Principal of Bharati College and the Director of Maharaja Surajmal Institute.

Mutual Understanding and Consent

All collaborations will be based on mutual interest and consent. No party shall be bound to participate in any activity unless it agrees to the specific terms of that activity.

No Legal or Binding Obligation

This MoU is not intended to be legally binding but reflects a spirit of academic cooperation and shared objectives.

Proposed Areas of Collaboration (illustrative only)

Exchange of faculty for guest lectures and academic discussions

Short-term student exchange programs for UPSC Coaching, projects or workshops

Joint organization of Seminars/workshops/conferences/competitions and cultural events

Collaborative research or publication opportunities.

Validity and Review

This MoU shall remain valid for a period of one year (1) year from the date of signing and can be renewed upon mutual agreement. Either party may withdraw from the MoU by giving 30 days' prior written notice to the other.
