SOCIETY FOR ALL ROUND DEVELOPMENT (SARD) (Party B) will be responsible for providing:


1. Information relating to Internship/ Apprenticeship/ Community Outreach opportunities to Party A
2. Equal consideration for Voluntary engagement/ employment to recommended students by Party A during the selection process.
3. Support to College's faculty supervisor in the coordination of the student's work experience activities and scheduling for voluntary work.
4. Offer/ Appointment letter to the selected students for voluntary work.
5. Student with meaningful work assignments (60 hours in a semester) which will enhance and complement the student's skill set and also met the organization goals or contribute for project deliverables.
6. Work experience certificate to the students on successful completion of the Internship/ Apprenticeship/ Community Outreach work.
