This MoU shall be valid for one year from the date of signing unless terminated earlier by mutual agreement.

#### **Confidentiality:**

Both parties agree to maintain the confidentiality of any proprietary information shared during the course of this collaboration.

#### **Governing Law:**

This MoU shall be governed by and construed in accordance with the laws of [Jurisdiction].

#### **No Financial Liability**

Both parties acknowledge and agree that this Memorandum of Understanding (MoU) does not create any financial obligations or liabilities between the parties. Each party shall bear its own costs and expenses incurred in connection with the negotiation, preparation, execution, and performance of this MoU. Neither party shall be liable to the other for any expenses, losses, damages, or other costs arising out of or in connection with this MoU or its termination.

This clause shall remain in effect even after the termination or expiration of this MoU.

#### **Requirements**

To fulfill the Memorandum of Understanding (MoU), the following infrastructure and other requirements must be met:



### **1. Human Resources**

### **2. Communication and Collaboration**

- Communication platforms and regular meetings for effective coordination.

### **3. Physical Infrastructure**

- Physical space, security measures, and a conducive work environment.

Both parties agree to ensure these requirements are met and maintained throughout the MoU's duration.

### **Data Confidentiality**

Both parties acknowledge and agree that any data provided or collected under this Memorandum of Understanding (MoU), including but not limited to student information, shall be treated as confidential. The receiving party shall:

#### **1. Confidentiality and Security**

- Maintain the confidentiality of the data and implement appropriate security measures to protect it from unauthorized access, disclosure, or use.

#### **2. Restricted Use**

- Use the data solely for the purposes outlined in this MoU and not for any other purposes.

#### **3. Non-Disclosure**

- Not disclose the data to any third party without the prior written consent of the disclosing party, except as required by law.

#### **4. Access Control**

- Restrict access to the data to only those employees or agents who need it to fulfill the purposes of this MoU and ensure that such individuals are bound by similar confidentiality obligations.

#### **5. Data Return or Destruction**

- Upon termination or expiration of this MoU, or upon the disclosing party's request, promptly return or securely destroy all data in its possession.

This clause shall remain in effect even after the termination or expiration of this MoU.

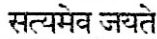

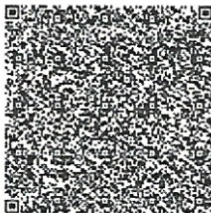
